The Keokuk County Board of Supervisors met in regular session, Monday, November 18, 2024, in the Board Room of the Courthouse. Present were: Michael C. Hadley, Daryl Wood, Fred Snakenberg and Christy Bates, Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Fred Snakenberg seconded the motion. All ayes and motion carried. Also present was Casey Jarmes, News-Review.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Fred Snakenberg to approve the minutes for November 12, 2024 as submitted. Deke Wood seconded the motion. All ayes and motion carried.

9:20 a.m.- Discussion of old/new business and public comment was held. Christy Bates informed Keokuk County is to continue the current construction permit process with the DNR. Christine Edmundson Long, Treasurer, entered the Boardroom and discussed the accrued interest on GO Bond money.
