Weber moved, Wood seconded to approve the agenda. All ayes and motion carried. Casey Jarmes, News Review, was present.

Wood moved, Weber seconded to approve the minutes of February 24, 2025, as submitted. All ayes and motion carried.

Weber moved, Wood seconded acknowledgement of personnel report for the full-time hire of Stephanie Tusing, LPN, Public Health Department as submitted. All ayes and motion carried.

Met with Charles Kent, IT Department, regarding additional network backup/improvement was held. Also present was Drew Sanders, Assessor/GIS. Chuck requested to add MCG internet fiber to the Courthouse at twice the speed, half the cost and with no contract requirement. Drew shared issues with the current provider as being extremely slow of which delays processing. Chuck informed Lisco will be cancelled once the contract is up. Board consensus was to allow moving forward with said request.

Various Board and Committee reports were held. Wood attended BOOST, 1015 Transit, RPA and Assessor's Conference Board meetings. Hadley attended Area 15 and Assessor's Conference Board meetings. Weber attended the Assessor's Conference Board meeting last week.

Discussion of old/new business and public comment was held. The proposed property tax notice will be published in the March 12th News-Review and a letter will be sent out to property owners on or prior to March 15, 2025. Cunningham maintenance established a new board and motor is needed for the outdoor HVAC system two unit that will be covered by warranty. Atwood Electric electrician traced the loss of power to low voltage of the generator. Ace Electric was contacted to check the generator.

On vote and motion Hadley adjourned the meeting at 9:50 a.m.
