

**KEOKUK COUNTY BOARD PROCEEDINGS  
APRIL 7, 2025**

The Keokuk County Board of Supervisors met in regular session, Monday, April 7, 2025, in the Board Room of the Courthouse. Present were Michael C. Hadley, Daryl Wood, Kevin Weber and Christy Bates, County Auditor.

Wood moved, Weber seconded to approve the agenda. All ayes and motion carried. Casey Jarmes, News Review, and Ashton Thomas were present.

Weber moved, Wood seconded to approve the minutes of March 31, 2025 as submitted. All ayes and motion carried.

Wood moved, Weber seconded to proclaim April as Child Abuse Prevention month as requested. All ayes and motion carried. Tammy Kesterson spoke of programs funded by Decat and community partnerships to protect children and provide a safe, structured learning environment and child abuse of various levels continue to rise.

Met with Engineer McGuire regarding the Keokuk County Highway Department as follows: met with MCG regarding updating security cameras; plans to apply for the Department of Transportation DARA grant and Keokuk County was awarded the Highway Safety Improvement grant in the amount of \$500,000 towards a portion of the Pigeon Road project.

Public hearing regarding vacating right of way in Van Buren township, Section 15, along V45 (200<sup>th</sup> Avenue) was held. No oral or written objections were received. Wood moved, Weber seconded to close the public hearing at 9:10 a.m. All ayes and motion carried.

Discussion of old/new business and public comment was held. A letter was received from the City of Sigourney notifying of a public hearing request for a zoning variance regarding use of first floor buildings as dwelling units to be held on April 8, 2025 at noon. Ashton Thomas, Keota High School graduate, informed he was present due to a requirement of Ag Leadership college course to attend a county Board of Supervisors meeting. The FY26 Keokuk County budget public hearing will be held next week on April 14, 2025.

On vote and motion Hadley adjourned the meeting at 9:40 a.m.
