8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Kevin Weber seconded the motion. All ayes and motion carried. Casey Jarmes, News Review, was present.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Kevin Weber to approve the minutes of April 14 2025 as submitted. Deke Wood seconded the motion. All ayes and motion carried.

9:30 a.m.- Discussion of old/new business and public comment was held. Notice was received from Employee Benefit Systems (EBS) that a \$25 fee will be charged for a third time reissuance of uncashed insurance checks. Board consensus was to establish a policy charging the employee offender for the \$25.00 fee. Stacy Flynn requested to meet with the Board to discuss the possibility of becoming the county's ICAP insurance agent. Board consensus was to schedule her for an upcoming agenda. Upon review of custodian applicants, individuals were chosen to be scheduled for interview on April 25th with a possible decision thereafter.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:40 a.m.
