The Keokuk County Board of Supervisors met in regular session, Monday, June 2, 2025, in the Board Room of the Courthouse. Present were Michael C. Hadley, Daryl Wood, Kevin Weber and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda as submitted. Kevin Weber seconded the motion. All ayes and motion carried. Casey Jarmes, News Review, was present.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Kevin Weber to approve the minutes of May 27, 2025 as submitted. Deke Wood seconded the motion. All ayes and motion carried.
