Weber moved, Wood seconded approval of personnel report for hire of Chad D. Cheney, full-time Jailer/Dispatcher, Sheriff’s Department, as submitted. All ayes and motion carried.

Wood moved, Weber seconded approval of Keokuk County Fiscal Year 2024/2025 Annual Financial Report as submitted. All ayes and motion carried. Bates summarized the report as factual year-end figures noting the ending balances per fund.

Various Board and Committee reports were held. Wood attended a monthly 1015 Transit and 1015 Transit/City of Ottumwa meetings. Weber had no scheduled meetings last week.

Discussion of old/new business and public comment was held. Bates informed she was approached regarding the need to appoint an additional medical examiner investigator and reminded that Ashley Willson had previously shown interest. Board consensus was to contact Ashley and start the process if interested. Taylor Zehr had also reached out to discuss EMS as Essential Service and possibly schedule a meeting once researched further.

On vote and motion Wood adjourned the meeting at 9:30 a.m.
