The Keokuk County Board of Supervisors met in regular session, Monday, December 1, 2025, in the Board Room of the Courthouse. Present were Michael C. Hadley, Daryl Wood, Kevin Weber and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Kevin Weber to approve the agenda as submitted. Deke Wood seconded the motion. All ayes and motion carried. Also present was Casey Jarnes, News-Review.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Deke Wood to approve the minutes of November 24, 2025, as submitted. Kevin Weber seconded the motion. All ayes and motion carried.

8:45 a.m. – Meeting with Andy McGuire, Engineer, regarding the Keokuk County Highway Department was held. Blades ran on pavement and gravel roads on Saturday until the wind picked up and then were back out again on Sunday to clear the snow. Andy noted the ground was soft making blading difficult not to push rock in the ditches. 9:35 a.m.- Discussion of old/new business and public comment was held. Pie Reighard, Conservation Director, stopped in to request worksheets and discuss his FY27 budget of which prompted further discussion regarding possible upcoming budget obstacles and union negotiations.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 10:00 a.m.
