

**BOARD MINUTES  
FEBRUARY 2, 2026**

The Keokuk County Board of Supervisors met in regular session, Monday, February 2, 2026, in the Board Room of the Courthouse. Present were: Michael C. Hadley, Daryl Wood, Kevin Weber, and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Kevin Weber to approve the agenda. Deke Wood seconded the motion. All ayes and motion carried. Also present were Casey Jarmes, News-Review, Darin Hite, IT and Pie Reighard, Stratton Bond, Aaron Kephart, Conservation.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Deke Wood to approve the minutes of January 26, 2026, as submitted. Kevin Weber seconded the motion. All ayes and motion carried.

8:45 a.m. -Met with Andy McGuire, Engineer, regarding Keokuk County Highway Department. Andy reported the snow was heavier in the west portion of the county, noting the intersections can be slick. Trucks are running this morning to clear snow. Also mentioned anything that can be salvaged from the DERA trucks is done prior to scraping. A wrecked pup chassis was purchased for pennies on the dollar as a project. Upcoming box culvert project paperwork is being worked on. No correspondence has been received to date regarding the union negotiations. Language in a tentative agreement must be accepted prior to proceeding to contract approval.

9:10 a.m. – Discussion and possible approval regarding implementation of Keokuk County AI (artificial intelligence) policy was held with Darin Hite, IT. The purpose of said policy is a form of protection for the county as a security measure to police what employees are using AI for and make them aware of what level they should be using. Motion was made by Deke Wood to approve the AI policy as submitted. Kevin Weber seconded the motion. All ayes and motion carried.

9:15 a.m. - Various Board and Committee reports were held. Deke Wood attended a RUSS meeting. Kevin Weber attended the Statewide Supervisors meeting. Mike Hadley attended Sieda, REDI, Area 15, Endowment and the Statewide Supervisors meeting last week.

9:05 a.m.- Discussion of old/new business and public comment was held. Denise Ballard provided health insurance rates from IGHCP at an overall increase of 2.66% for FY2027. Mike Hadley suggested increasing the employees’ share of premium by \$10.00 per month. All members concluded that small step increases are more financially beneficial to employees than a large increase at once. Board consensus is to increase the employees’ share of monthly premium by \$5.00 per pay period to begin July 1, 2026. Paul Horak provided an estimated rate increase for county property, buildings, equipment and vehicles from ICAP at an overall increase of estimated 10%. Board discussion arose regarding agents and each member indicated they are comfortable with the service Paul provides for Keokuk County and therefore consensus is to remain with Horak Insurance.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:45 a.m.
