

**BOARD MINUTES  
FEBRUARY 9, 2026**

The Keokuk County Board of Supervisors met in regular session, Monday, February 9, 2026, in the Board Room of the Courthouse. Present were: Michael C. Hadley, Daryl Wood, Kevin Weber, and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Kevin Weber to approve the agenda. Deke Wood seconded the motion. All ayes and motion carried. Also present was Casey Jarnes, News-Review.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Deke Wood to approve the minutes of February 2, 2026, as submitted. Kevin Weber seconded the motion. All ayes and motion carried.

8:40 a.m. -Discussion and possible approval of re-appointment of Tom Hotchkiss to the Keokuk County Conservation Board for a five-year term was held with Pie Reighard, Conservation Director. Motion was made by Kevin Weber to approve the Hotchkiss re-appointment as submitted. Deke Wood seconded the motion. All ayes and motion carried.

8:45 a.m. – Approval to ratify re-appointment of Allan Glandon to the Keokuk County Conservation Board for a five-year term beginning January 1, 2024 was held with Pie Reighard, Conservation Director. Motion was made by Deke Wood to approve the ratification of Glandon re-appointment as submitted. Kevin Weber seconded the motion. All ayes and motion carried.

8:50 a.m. – Consideration and possible approval of Keokuk County Bowl Class C liquor license (LC) application was held. All documents were in order. Motion was made by Kevin Weber to approve the Class C liquor license as submitted and to authorize the Chairman to sign on behalf of Keokuk County. Deke Wood seconded the motion. All ayes and motion carried.

8:55 a.m. - Acknowledgement of personnel report for Johnathon Klett, Field Assistant, Assessor’s Office was held. Motion was made by Deke Wood to acknowledge the Klett, Field Assistant, termination as submitted. Kevin Weber seconded the motion. All ayes and motion carried.

9:00 a.m. - Various Board and Committee reports were held. Deke Wood attended a Pathfinders meeting and met with Andrew McGuire, Engineer and Marionnette Miller-Meeks regarding acceptance of grant funding for the west half of the Pigeon Road. Kevin Weber attended a Decat meeting. Mike Hadley had no scheduled meetings last week.

9:10 a.m.- Discussion of old/new business and public comment was held. The FY27 budget was discussed, including the county contribution amount for Emergency Management.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:25 a.m.
