9:40 a.m. – Certification of expenses for March 3, 2026, Special Keota School Election was held. The total of various costs incurred equated to the amount of \$2,024.61. Motion was made by Kevin Weber to approve said certification of expenses as submitted and to authorize the Chairman of the Board of Supervisors to sign on behalf of Keokuk County. Deke Wood seconded the motion. All ayes and motion carried.

9:45 a.m. - Various Board and Committee reports were held. Deke Wood attended Farm Bureau and Assessor Conference Board meetings. Kevin Weber attended a Farm Bureau meeting. Mike Hadley attended a Semco meeting last week.
