8:45 a.m. – Review and approval of quarterly report of fees collected by the County Auditor and Sheriff and monthly report of fees collected by the County Recorder and Clerk of Court was held. Motion was made by Daryl Wood to approve the fees as submitted. Kevin Weber seconded the motion. All ayes and motion carried.

8:50 a.m. - Various Board and Committee reports were held. Kevin Weber attended District Early Childhood and Keokuk County website meetings. Mike Hadley attended a Semco meeting. Deke Wood had no scheduled meetings last week.

8:55 a.m.- Discussion of old/new business and public comment was held. Patrick Lalla, Keokuk County Paramedic, Sigourney Fire & Rescue & Iowa County Reserve Deputy was present to discuss the alleged indiscretions regarding accountability and professionalism of the Keokuk County Sheriff and Sheriff's Department and why the Board of Supervisors are not addressing said public concerns. The Board of Supervisor's responded this matter has been referred to the Iowa Law Enforcement Academy (ILEA) for investigation and are currently awaiting a response. Also clarified was the Sheriff is an elected official, and therefore they are only in control of the Sheriff's Department budget. Lalla then inquired about the additional \$10,000 raise given to the Sheriff noting the alleged indiscretions. The Board responded that they were legally obligated to comply with Iowa code Section 331.907-Compensation Schedule a/k/a the Back the Blue Law and Iowa Code Section 341A-Civil Service for Deputy County Sheriffs.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:50 a.m.

The Keokuk County Board of Supervisors adjourned to meet Monday, April 27, 2026.
