MAY 11, 2026

The Keokuk County Board of Supervisors met in regular session, Monday, May 11, 2026, in the Board Room of the Courthouse. Present were: Michael C. Hadley, Daryl Wood, Kevin Weber, and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Kevin Weber to approve the agenda. Deke Wood seconded the motion. All ayes and motion carried.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Deke Wood to approve the minutes of May 4, 2026, as submitted. Kevin Weber seconded the motion. All ayes and motion carried.

8:45 a.m. – Met with Andy McGuire, Engineer, regarding Keokuk County Highway Department was held. Andy provided a 2026 Keokuk County Five Year Program Resolution 1.1 regarding the Secondary Roads department modification to include L-711435—73-54 Bridge 711435 replacement 51138 project to be signed by the Chairman of the Board of Supervisors and approved by the Iowa Department of Transportation (Iowa DOT).

9:20 a.m. – Review and possible approval of July 4th Committee application for use of Courthouse Grounds for July 1 – 5, 2026 was held. Proof of insurance was provided. Motion was made by Kevin Weber to approve the application as submitted. Deke Wood seconded the motion. All ayes and motion carried.

9:25 a.m. –Setting date, time and location for Keokuk County Secondary Roads FY26 Budget amendment public hearing was held. Motion was made by Mike Hadley to approve Tuesday, May 26, 2026 at 9:00 a.m. in the Boardroom, 1st floor, of the Keokuk County Courthouse as submitted. Deke Wood seconded the motion. All ayes and motion carried.

9:30 a.m. – Review and possible approval of contract to provide professional consulting services by Cost Advisory Services, Inc. (CASI) was held. The three-year contract reflects the previous contract verbiage. Motion was made by Deke Wood to approve the CASI contract as submitted and to authorize the Chairman of the Board of Supervisors to sign on behalf of Keokuk County. Kevin Weber seconded the motion. All ayes and motion carried.

9:35 a.m. - Various Board and Committee reports were held. Deke Wood attended a quarterly Pathfinders meeting. Kevin Weber attended a Decat meeting. Mike Hadley had no scheduled meetings to attend last week.

9:35 a.m.- Discussion of old/new business and public comment was held. Keokuk County has been scheduled for Monday, June 8, 2026 as the Iowa State Association of Counties (ISAC) Tour date that will provide an overview of ISAC programs and legislative activity to elected and appointed officials and employees, that will then be opened up for a question and answer session. Clock tower project update was held as follows: two vendors have provided a quote to date with a couple others waiting on information.
