JUNE 8, 2026

The Keokuk County Board of Supervisors met in regular session, Monday, June 8, 2026, in the Board Room of the Courthouse. Present were: Michael C. Hadley, Kevin Weber and Christy Bates, County Auditor. Daryl Wood was absent.

8:30 a.m. – Meeting was called to order. Motion was made by Kevin Weber to approve the agenda as submitted. Mike Hadley seconded the motion. All ayes and motion carried.

8:35 a.m.- Review and approval of previous board meeting minutes was held. Motion was made by Mike Hadley to approve the minutes of June 1, 2026 as submitted. Kevin Weber seconded the motion carried. All ayes and motion carried.

8:45 a.m. - Met with Casey Clarahan, Engineer’s Assistant regarding the Keokuk County Highway Department.

1.Consideration and possible approval of resolution to set the date, time and location for a public hearing for a road vacation, including the sale and conveyance of Keokuk County Bridge 401498 to Jerry Hartnell, on 328th Avenue between 310th Street and 305th Street in Section 14, Township 74N, Range 10W Richland Township was held. Motion was made by Kevin Weber to set the public hearing for June 22, 2026 at 9:00 a.m. in the Boardroom, 1st floor of the Keokuk County Courthouse. Mike Hadley seconded the motion. All ayes and motion carried.

9:00 a.m.- Discussion and possible approval of agreement between Keokuk County, Iowa Secondary Roads Department, and Public, Professional and Maintenance Employees (PPME) Local No 2003 International Union of Painters and Allied Trades, AFL-CIO was held. The agreement duration is July 1, 2026 to June 30, 2029, wages shall be open for negotiations effective July 1, 2027 and July 1, 2028 under Article 27. Motion was made by Mike Hadley to approve the PPME Local No 2003 agreement for July 1, 2026 to June 30, 2029 as submitted. Kevin Weber seconded the motion carried. All ayes and motion carried.

9:20 a.m. – Review and approval of Keokuk County Certification of FY 2027 salaries was held. Motion was made by Kevin Weber to approve said FY2027 salary certification as submitted. Mike Hadley seconded the motion. All ayes and motion carried.

9:25 a.m.- Various Board and Committee reports were held. Mike Hadley attended a Sieda meeting. Kevin Weber had no scheduled meetings to attend last week.

9:35 a.m.-Discussion of old/new business and public comment was held. Inquiries were received from RS Tuckpointing and TnT Tuckpointing regarding status of the clock tower project. This matter will be discussed further with the full Board of Supervisors next week.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:45 a.m.
