The Keokuk County Board of Supervisors met in regular session, Tuesday, August 18, 2026, in the Board Room of the Courthouse. Present were Michael C. Hadley, Kevin Weber, and LuAnn Berger, recording secretary. Absent was Daryl Wood, Supervisor; and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Mike Hadley to approve the agenda. Kevin Weber seconded the motion. All ayes and motion carried.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Kevin Weber to approve the minutes of August 10, 2026, as submitted. Mike Hadley seconded the motion. All ayes and motion carried.
