

BOARD MINUTES
MARCH 6, 2023

The Keokuk County Board of Supervisors met in regular session, Monday, March 6, 2023 in the Board Room of the Courthouse. Present were: Michael C. Hadley, Fred Snakenberg, Daryl Wood and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Fred Snakenberg seconded the motion. All ayes and motion carried. Also present was Casey Jarnes, News-Review.

8:35 a.m. - Review and approval of minutes of previous board meeting was held. Motion was made by Fred Snakenberg to approve the minutes of February 27, 2023 as submitted. Deke Wood seconded the motion. All ayes and motion carried.

8:45 a.m. - Met with Engineer Andy McGuire regarding the Keokuk County Highway Department.

1. Review and possible approval of funding agreement for V5G PCC Overlay Project, project number HDP-C054 (121)-6B-54 was held. Andy reminded this federally funded grant awarded by Miller-Meeks to resurface the stretch of road from Hwy 149 to 180th Street. Motion was made by Deke Wood to approve the V5G overlay project funding agreement as submitted. Fred Snakenberg seconded the motion. All ayes and motion carried.

2. Review and possible approval of final plans for V5G PCC Overlay Project, project number HDP-C054 (121)-6B-54 was held. Motion was made by Fred Snakenberg to approve the V5G overlay project final plans as submitted. Deke Wood seconded the motion. All ayes and motion carried.

3. Review of bids and possible award of contract for salt storage structure was held. Three bids were received as follows: Greenfield Contractors - \$107,943 / \$114,743 includes stainless steel cable; Graystone (Lamusga bidder) - \$126,800; Miles Wellman Construction Inc - \$140,353. Motion was made by Deke Wood to approve Greenfield Contractors (low bid) of \$114,743 to include stainless steel cable as submitted. Fred Snakenberg seconded the motion. All ayes and motion carried.

4. Review and possible approval of resolution 2023-3-6-A to authorize the application of a FY2024 Community Project funding request to resurface a portion of County Route G13 was held. Communication was received regarding Miller-Meeks federal funded grant application that is due March 16th, of which he would like to submit an application to resurface the west ½ of Pigeon Road. Motion was made by Fred Snakenberg to approve submittal of funding request application for G13 overlay project as requested. Deke Wood seconded the motion. All ayes and motion carried.

9:15 a.m.- Review and approval of claims listing dated March 6, 2023 was held. Motion was made by Deke Wood to approve the claims listing as submitted. Fred Snakenberg seconded the motion. All ayes and motion carried.

Clarification regarding City of Sigourney use of the waste/recycling center south of Sigourney was provided by Cox Sanitation as follows: City of Sigourney residents, not businesses, may take household recycling may take household recycling to the facility as per the City/County 28E Agreement. A dumpster may be rented from Cox for cardboard and picked up monthly. Said facility has limited space and is unable to accommodate large quantities of recycling materials at a time. All inquiries are to be directed to Cox Sanitation. The FY24 Keokuk County budget was review. Setting of the public hearing for the proposed max levy will be placed on the March 13th agenda.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:35 a.m.
