

**BOARD MINUTES**  
**APRIL 22, 2024**

The Keokuk County Board of Supervisors met in regular session, Monday, April 22, 2024, in the Board Room of the Courthouse. Present were: Michael C. Hadley, Daryl Wood, Fred Snakenberg and Christy Bates, Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Fred Snakenberg seconded the motion. All ayes and motion carried. Also present was Casey Jarnes, News-Review.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Fred Snakenberg to approve the minutes for April 15, 2024 as submitted. Deke Wood seconded the motion. All ayes and motion carried.

8:45 a.m. – Meeting with Andy McGuire, Engineer regarding the Keokuk County Highway department. Andy attended the National Association of County Engineers (NACE) meeting last week where he was elected as a South-Central Regional NACE Vice-President. Group networking and discussion took place regarding technical sessions and streamlining disaster recovery. The 2004 Chevy Silverado pickup will have rusty rocker panels fixed and replacement of aluminum flatbed. A crusher is being hired to crush the pile of asphalt at the county shop so it can be used. The V5G patching is done with projection of 24’ width paving to begin in two to three weeks.

9:25 a.m. - Discussion and possible approval of Keokuk County Economic Development application for use of Courthouse grounds on June 5, 2024 through September 25, 2024 for Farmer’s Market was held. All paperwork is in order. Motion was made by Deke Wood to approve the application as submitted. Fred Snakenberg seconded the motion. All ayes and motion carried.

9:28 a.m. - Discussion and possible approval of Keokuk County Economic Development application for use of Courthouse grounds on July 20, 2024 for Sigourney Car Show was held. All paperwork is in order. Motion was made by Fred Snakenberg to approve the application as submitted. Deke Wood seconded the motion. All ayes and motion carried.

9:30 a.m. – Various Board and Committee reports were held. Fred Snakenberg participated in a Early Childhood meeting. Mike Hadley attended Semco, Endowment, Sieda and dealt with Waste Service Agency matters. Deke Wood had no scheduled meetings last week.

9:10 a.m.- Discussion of old/new business and public comment was held. Christy Bates informed the American Rescue Plan Act report has been submitted for the year, further noting the balance of funds must be designated prior to December 2024. Deke Wood reminded he would be absent from next week’s meeting.
