

**BOARD MINUTES**  
**APRIL 29, 2024**

The Keokuk County Board of Supervisors met in regular session, Monday, April 29, 2024, in the Board Room of the Courthouse. Present were: Michael C. Hadley, Fred Snakenberg and Christy Bates, Auditor. Daryl Wood was absent.

8:30 a.m.- Meeting was called to order. Motion was made by Mike Hadley to approve the agenda. Fred Snakenberg seconded the motion. All ayes and motion carried. Also present was Casey Jarmes, News-Review.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Fred Snakenberg to approve the minutes for April 22, 2024 as submitted. Mike Hadley seconded the motion. All ayes and motion carried.

8:45 a.m. – Meeting with Andy McGuire, Engineer regarding the Keokuk County Highway department. Andy received a call from Marionette Miller-Meeks regarding the grant application for financial assistance for continuance of paving the Pigeon Road, highlighting the project is shovel ready if awarded. The weekend storm took down a couple of trees that had to be cleaned up and damaged the overhead door on the Hedrick maintenance shed that required attention to make functional. Andy shared additional topics discussed at the National Association of County Engineers meeting last week and responsibilities tied to his newly elected position as South-Central Regional NACE Vice-President.

9:15 a.m. – Review and possible approval of listing of Keokuk County residents that qualify for tax suspension pursuant to Section 427.9 of the Code of Iowa was held. Motion was made by Fred Snakenberg to approve the application as submitted. Mike Hadley seconded the motion. All ayes and motion carried.

9:30 a.m. – Various Board and Committee reports were held. Mike Hadley attended Board of Health and dealt with Area 15 financial and Waste Service Agency matters. Fred Snakenberg had no scheduled meetings last week.

9:10 a.m.- Discussion of old/new business and public comment was held. Board consensus was to approve Sigourney Treecare for tree cleanup on county property across from the old county shop. Health insurance options continue to be explored. Jeff Kiebel, Custodian, entered to discuss the leak reported in the courtroom.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:20 a.m.
