8:45 a.m. – Meeting with Andy McGuire, Engineer, regarding Keokuk County Highway Department.

1. Presentation from Dr. Bora Cetin with Michigan State University regarding Iowa Highway Research project on 190<sup>th</sup> Street (rural Keota) was held. Jacob Thorius, Washington County Engineer, was also present due to involvement in said project. Engineer McGuire informed said road was chosen due to being a farm to market road that receives a lot of travel, including hog confinement activity. Dr. Cetin explained Keokuk County lies within Region III (wet/hard freeze/spring thaw) of which is good for farming but not roads. The purpose of the project is to make the soil water resistant by lowering the ground water/moisture content by various tactics and evaluate the four cells of test sites regarding effectiveness versus cost.
