9:10 a.m.- Review and possible approval of City of Sigourney use of Courthouse grounds application for July 4<sup>th</sup> Celebration (June 30 – July 4, 2023) was held. Motion was made by <u>Deke Wood</u> to approve the request as submitted. <u>Fred Snakenberg</u> seconded the motion. All ayes and motion carried

9:15 a.m. – Meeting to discuss the Home Base Iowa Program with Jathan Chicoine and Mike Cockrun. Also present was Michelle Herman, Veterans Affairs/Community Services Administrator, Keith Blair and Jerry Whitehurst, Veterans Affairs Commissioners. The purpose of the program is to bridge the work force, higher education and community support gap with veterans. Keokuk County Economic Development, fka SADC, will be asked to spearhead and promote this program. Requirements include the Board of Supervisors passing a membership resolution, offer meaningful incentives for relocation, purchase and post HBI signs (\$74 per sign) and hold a designation ceremony celebration.

9:35 a.m. – Meeting with Kiwanis representatives to discuss progress of pavilion project was tabled due to waiting on estimates.

9:36 a.m. – Various Board and Committee reports was held. Deke Wood attended RUSS and Crime Commission meetings. Fred Snakenberg participated in a SEIL regional mental health meeting. Mike Hadley attended a Freight Council meeting last week.

9:45 a.m.- Discussion of old/new business and public comment was held. Christine Edmundson Long, Treasurer, shared there are 549 bidders for the 211 parcels involved in the tax sale. The Veterans Affairs Administrator and Commissioners inquired of moving to first floor and also placement of a 20' cube storage container at the old shop. The Veterans Memorial site around the flag on the northwest corner is currently being worked on. Board consensus was removal of the dying tree located on the east side due to the majority being full of dead branches.

There being no further business, motion to adjourn was made by <u>Mike Hadley</u>. All ayes and the meeting adjourned at 10:15 a.m.
