9:10 a.m.- Discussion of old/new business and public comment was held. A letter was sent in support of the Dakota Access Pipeline (DAPL) noting the financial benefit gained through property tax paid by DAPL. Don Arduser sent notice stating he would be interested in mowing the recycling center property next year as well. Board consensus was to accept his request. Discussion arose regarding how fire jurisdiction maps were originally established by following phone lines and correlating township levies.

There being no further business, motion to adjourn was made by Mike Hadley. All ayes and the meeting adjourned at 9:30 a.m.
