The Keokuk County Board of Supervisors met in regular session, Monday, August 21, 2023, in the Board Room of the Courthouse. Present were: Michael C. Hadley, Daryl Wood, Fred Snakenberg and Christy Bates, County Auditor.

8:30 a.m.- Meeting was called to order. Motion was made by Deke Wood to approve the agenda. Fred Snakenberg seconded the motion. All ayes and motion carried. Also present was Casey Jarmes, News-Review.

8:35 a.m. - Review and approval of previous board meeting minutes was held. Motion was made by Fred Snakenberg to approve the minutes of August 14, 2023, as submitted. Mike Hadley seconded the motion. Deke Wood abstained due to being absent from said meeting. Motion carried.

8:45 a.m. -Meeting with Keokuk County Highway Department was held. Adam Stevens informed his plan is to begin work on road patching the end of August.
